

Cookies are small text files that are placed on your computer by websites that you visit. Websites use cookies to help users navigate efficiently and perform certain functions. Cookies that are required for the website to operate properly are allowed to be set without your permission. All other cookies need to be approved before they can be set in the browser. You can change your consent to cookie usage at any time.

We use two types of cookies: (1) cookies that are strictly necessary for technical reasons, without which the website would not function properly, and (2) optional cookies, which include cookies for statistical purposes and cookies for marketing purposes.

## **Profiling:**

[m]insights and AppNexus Cookies monitor the browsing habits of visitors to the website and place ads in their web browser according to their browsing habits. These types of cookies do not process or transmit any personal data.

We do not use Optional Cookies without the user's prior consent. When the user first visits our website, a window will appear asking for consent to the use of Optional Cookies. If you consent, a cookie will be stored on your computer and the window will not appear again during the lifetime of the cookie. If the cookie expires or the user deletes the cookie, the next time the user visits our website, the window will reappear asking for consent.

By changing the settings in the table above, the user has the right to withdraw his/her consent to the use of Optional Cookies at any time. Of course, the user can use our website without cookies, including cookies used for technoval reasons. You may deactivate or restrict the use of cookies in your browser at any time, which may, however, have a negative impact on the usability of the site and its user-friendliness.


#### Web analysis:

Our website uses Google Analytics, a web analytics service provided by Google Inc.; 1600 Amphitheatre Parkway, Mountain View, CA 94043, United States ("Google").

The information generated by the cookies about the user's visit to the website is usually sent to a Google server in the United States and stored there. Google will shorten the user's IP address, but only in the member states of the European Union or other countries of the Agreement on the European Economic Area. Only in exceptional cases will the full IP address be sent to a Google server in the United States and shortened there. On behalf of the website operator, Google will use this information to evaluate your use of the website, compile reports on website activity for website operators and provide website operators with other services relating to website activity and internet usage.
